New types of cyberattacks are continuously emerging, creating acute challenges for countries and their efforts to detect and classify new behaviors' and malicious actors. Ransomeware, and other social engineering techniques, have increased during the pandemic An overwhelming majority of cybercrimes contain transnational elements, even when perpetrators and victims are determined to be at one location.		
		The issues surrounding effective cyber justice span detection, investigation, preservation of evidence, and prosecution of crimes. These tasks must occur against the backdrop of robust international cooperation among authorities and concerned actors. This keynote address will highlight specific Caribbean challenges and opportunities for delivering cyber-justice and bringing justice to the victims of cyber criminality.
