DIGITAL DEMOCRACY | CITIZEN PARTICIPATION

• Digital Democracy:

- Integrating technology into democratic processes / how government responds to needs of society using the technology
- Helps with citizen engagement, participation, transparency, inclusivity
- Open data

• Citizen Participation:

- Involve citizens in decisionmaking processes through:
- Voting, public consultations, community meetings
- Use of digital platforms for engagement (social media, polls, surveys)

CITIZEN PARTICIPATION IN DECISION-MAKING PROCESSES

 - Empowerment
 - Collaboration

CHALLENGES TO DIGITAL DEMOCRACY / CITIZEN ENGAGEMENT

- Privacy concerns
 - Online engagement often leads to sharing of personal data
 - Result: concerns about data protection and privacy and misuse of personal informatic
 - Legislation / regulations
- Digital divides
 - Not everyone has access to tools and platforms to participate in data sharing; affordability of broadband
 - **Result**: marginalized communities/individuals/groups being left out from digital democracy initiatives
- Selective participation
 - Online discussions being dominated by vocal minority groups leading to skewed perception of public opinion
 - **Result:** policies cater for a few rather than the majority of the population

DIGITAL PUBLIC INFRASTRUCTURE

- To learn about what SVG is doing, let's look at digital democracy from the concept of Digital Public Infrastructure (DPI):
 - DPI refers to the technological and organizational framework that supports the delivery of public services and information through digital means, such as:
 - digital tools, platforms, and systems that enable governments and public institutions to interact with citizens, provide services online, and manage public resources more efficiently
 - It is used to enhance government transparency, improve public service delivery, and promote citizen engagement
 - A robust DPI is essential for implementing and supporting the mechanisms of digital democracy.
