REGISTRATION AND ON-SITE IDENTIFICATION

Participant registration will be held at the First Floor of the Fiesta Bahia Hotel & Convention Center, starting at 07:30 AM on Monday, September 29.

Delegates must provide an official photo ID, such as a passport or identity card, to receive their credential, which must be worn throughout the event. Delegates wishing to use interpretation headsets must present an official ID card (other than a passport), which will be returned at the end of each day upon return of the headset.

Vaccination:

The Ministry of Health recommends that international travelers update their vaccination status according to their country of origin, especially for yellow fever, polio, measles, rubella, diphtheria, and tetanus.

Yellow fever vaccination is recommended at least 10 days before travel.

COVID-19 vaccination is not currently mandatory at airports but is recommended to have it with you.

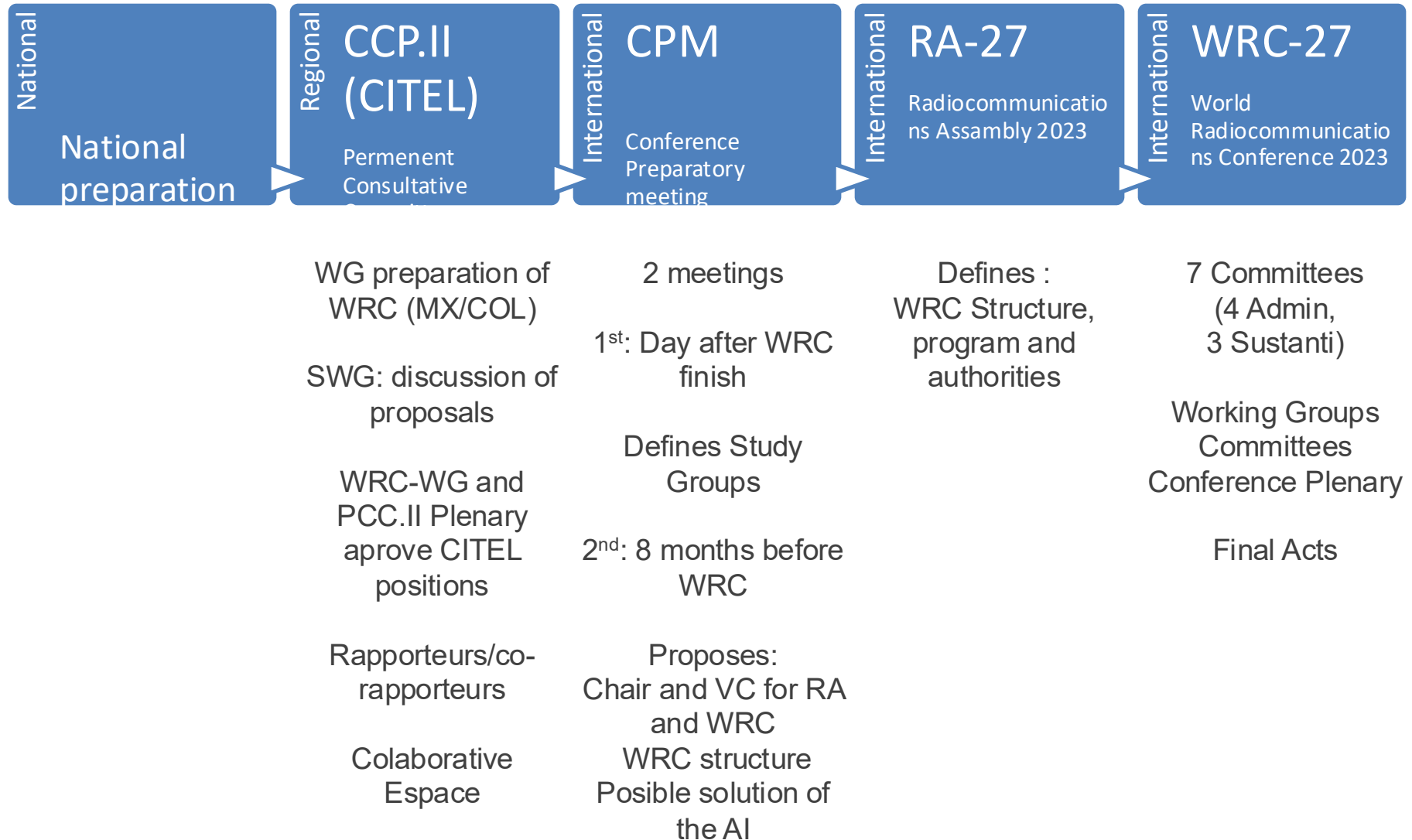
