The work of the SMTF will focus on the following thematic areas for 2025:

1. RFAT (Harmonisation of Priority Bands: IMT, Emergency Communications, IoT/Innovation bands e.g. Wi-Fi, DSA, TVWS etc. for bands NOT being addressed at WRC-27)
2. Harmonising spectrum management policies to facilitate new and emerging technologies and services for socio-economic development
3. Emergency Communications
4. Spectrum Pricing
5. WRC-27 Preparations
6. Planning Digital Broadcasting Switchover
7. Maintaining Current Information for Operational Coordination (to support Cross-border interference coordination and emergency communications)
