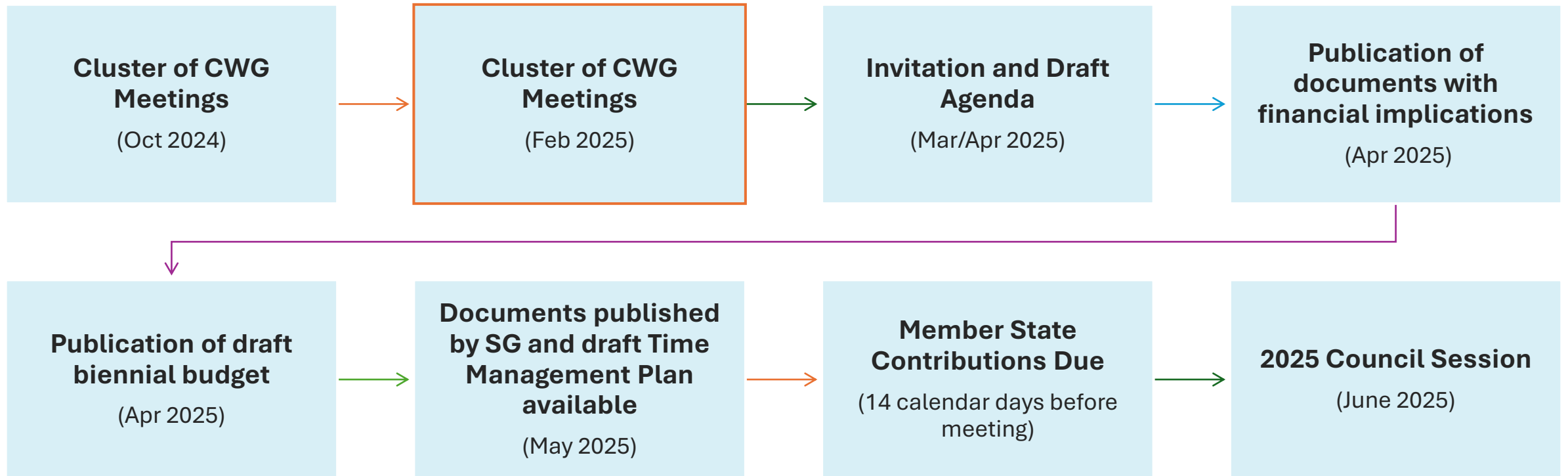

EG – ITRs

Mandate

To review and make recommendations on the **International Telecommunications Regulations (ITRs)**.

Meeting Dates	20-21 February
Contribution Deadline	8 February

Matters under Consideration

- New trends and emerging issues in the (international) telecommunications/ICT environment that may impact the ITRs.
- Empirical data on the current use of the ITRs by operating agencies and/or administrations and the proportion of global telecommunication services that now rely on the ITRs.
- The relevance of the ITRs, which “consist of high-level guiding principles” in the current telecommunication/ICT environment.

EG – Decision 482

Meeting Dates

Contribution Deadline

Mandate

Considers matters on the appropriateness of various aspects of **cost recovery for processing satellite network findings**.

Matters under Consideration:

- Secretariat’s Report on additional data and information on processing of satellite network filings*, **inter alia**:
 - Level of fees for non-receivable filings having regard for the needs of developing countries.
 - The extent to which complex non-GSO satellite system filings should not be eligible for free entitlement.
 - The cost of processing resubmissions of notification requests.
 - Consequences of WRC modifications after WRC-2000 to the Space Plans’ regulatory provisions.
 - Costs for updating Bureau software for satellite filings, with a clear separation from funding terrestrial filing tools.
 - Others
- Comprehensive review and possible revisions to Decision 482.

Oversees the use of the six languages of the Union on an equal footing.
